SE 1/4 Sec. 28 T20N R53E MM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 20 FEET IN A/N WEST DIRECTION, AND, 1180  
FEET IN A/N EAST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
