NE 1/4, SE 1/4 Sec. 28 T20N R53E MM. FROM THIS DISCOVERY MONUMENT, THE  
UNDERSIGNED CLAIMS 20 FEET IN AN/WEST DIRECTION, AND, 1480  
FEET IN A/EAST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
