Sec 28 T20N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE
UNDERSIGNED CLAIMS 20 FEET IN AN EAST DIRECTION, AND, 1480
FEET IN AN WEST DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
