The general course of the lode deposit and premises is from the NW to the SE.

The monumentation and marking of the corners was completed by the 30 day of SEPTEMBER, 1992.

(Must be within 20 days of posting notice of location) The location work consisted of making a claim map as provided in NRS 517.010. Two copies of this claim map have been filed with the EUREKA County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.
