The work consisted of drilling and catwork. The work described above was performed at the following location: ALAN #17.

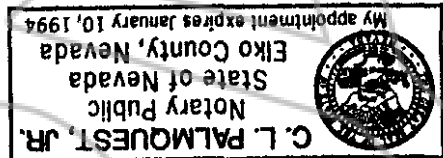
