25 After motion for summary judgment was filed by lien claimant

27 August 13, 1990, during which counsel for TONKIN SPRINGS GOLD
28 MINING COMPANY and U.S. GOLD CORPORATION stipulated to the entry
29 of judgment, summary judgment was entered by this court on
30 August 31, 1990. That judgment was in favor of WEYHER BROTHERS
31 COMPANY and against TONKIN SPRINGS GOLD MINING COMPANY on the
32 WEYHER BROTHERS lien claim in the amount of \$348,750.00, together
