

AFFIDAVIT OF LABOR

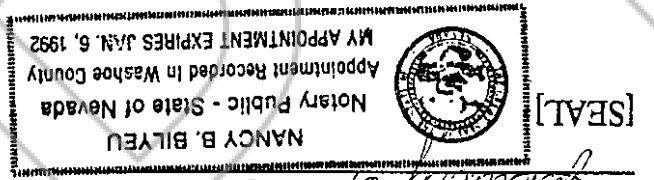

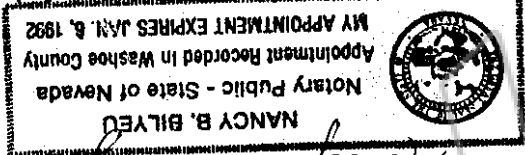
