

AFFIDAVIT OF LABOR

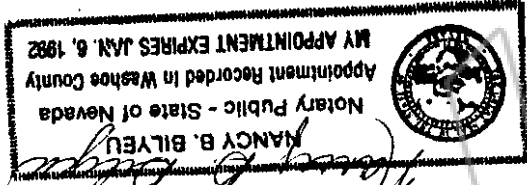
