The undersigned hereby certifies that he, on behalf of Newmont Gold Company, has caused to be located the 2NVE No. 15A Lode Mining Claim in the NE1/4, NW1/4, SW1/4 and SE1/4 of Section 36, Township 36 North, Range 49 East, M.D.M., in Eureka County, Nevada, on the 22nd day of August, 1990.

The general course of the lode or vein is from the East to the West direction.
