Gold Corporation, a Colorado corporation, for the amount of FOUR HUNDRED THIRTY THOUSAND SEVEN HUNDRED TWENTY EIGHT and 27/100ths DOLLARS (\$430,728.27), with interest thereon at a rate of interest allowed by federal law, together with taxable costs and attorney fees to be determined in accordance with Local Rules of Practice of the U. S. District Court.

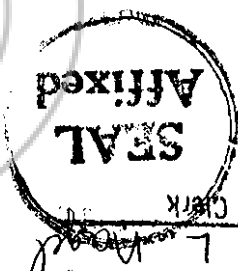
