Having met in open court on August 24, 1990, with respective counsel of record for the Plaintiff, Tonkin Springs Gold Mining Co., U. S. 6 foreclosure or execution are stayed until September 30, 1990.

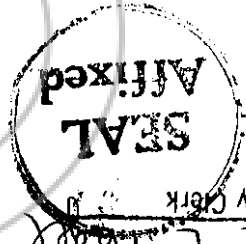
