TOGETHER with any and all buildings and improvements situate thereon.

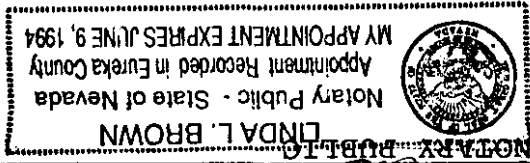
