to the survivors of them forever.

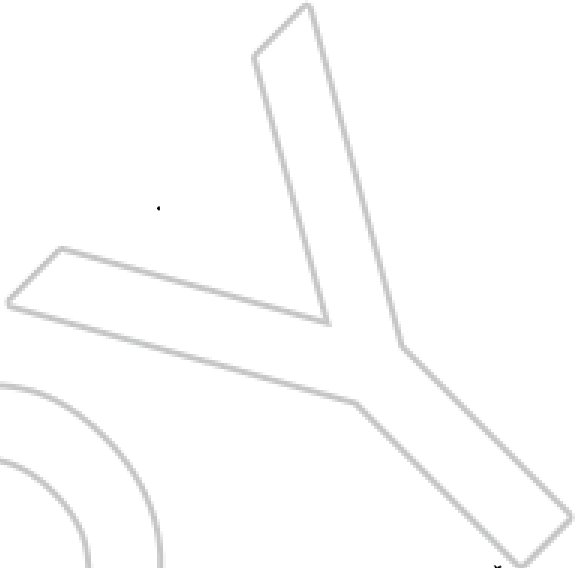
