The general course of the lode or vein is North and South.

We (or I) claim 1500 linear feet along the course of the lode, lode or vein, extending 1490 feet from the location monument in a Northerly direction and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
