To the this claim to the Public Survey, begin at the NW corner of Section 4, Township 17 North, Range 51 East, Mount Diablo Base and Meridian, thence 0 feet South and 10,200 feet East to the Northeast corner of this claim.

The general course of the lode or vein is North and South.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein,

extending 1490 feet from the location monument in a Northerly direction and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The exterior boundaries of this claim are clearly marked by substantial PVC Pipe Monuments, firmly set in the ground and bearing applicable monument designation. The description of such claim is: Beginning at the Northeast Corner:

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
