FROM NE CORNER SECTION 32, TOWNSHIP 20N, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NE 1/4 SECTION 32, T28N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE

UNDERSIGNED CLAIMS 20 FEET IN AN/SOUTH DIRECTION, AND, 1480 FEET IN A/NORTH DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
