FROM SW CORN Sec. 28, T28N R35E MDM. SAID CLAIM LIES WITHIN THE SW 1/4, RANGE 53E, MOUNT DIABLO MERIDIAN, NEVADA. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 70 FEET IN AN/AN SOUTH DIRECTION, AND, 180 FEET IN A/VAN NORTH DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
