THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1720 S 37 W, TOWNSHIP 20 N, RANGE 53 E, FROM NB 68N, SW 1/4 Sec. 28, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4, T28N R53E T28N R53E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 20 FEET IN AN/NW SOUTH DIRECTION, AND, 1280 FEET IN A/N NORTH DIRECTION, AND, 200 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 400 FEET WIDE AND 1300 FEET LONG.

LOCATION WORK FOR THIS MINING CLAIM CONSISTED OF PREPARING AND FILING A MAP OF SAID CLAIM AS PROVIDED IN NRS. 517.040.
