THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1120' S12°W, TOWNSHIP 25N, RANGE 50E, FROM NE CRN Sec. 4, MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NE 1/4 OF THE DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/AN SE DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
