FROM SE GRN NE 1/4 Sec. 4, TOWNSHIP 25 N, RANGE 50E
MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NE 1/4, SE 1/4
Sec. 4 T 25 N R 50E MDM. FROM THIS DISCOVERY MONUMENT, THE
UNDERSIGNED CLAIMS 10 FEET IN AN/AN SE DIRECTION, AND, 1490
FEET IN A/VAN NW DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
