THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 790' S36°E FROM NW CORNER SE 1/4 Sec. 4, TOWNSHIP 25N, RANGE 50E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4, SE 1/4, S36°E, FROM THIS DISCOVERY MONUMENT, THE UNDERLINED CLAIMS 10 FEET IN AN/AN NE DIRECTION, AND, 1190 FEET IN A/AN SE DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1200 FEET LONG.
