FROM OLD CRN NE 1/4 Sec. 4, TOWNSHIP 25 N, RANGE 50 E
MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SE 1/4 Sec. 33 T26N R9E,
UNDERSIGNED CLAIMS 700 FEET IN AN/AN NE DIRECTION, AND, 800
FEET IN A/AN SE DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
