THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 900' N 10W FROM SE CORN SW 1/4 Sec. 34, TOWNSHIP 26 N, RANGE 50E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4 SE 1/4 FROM SE CORN SW 1/4 Sec. 34 T26 N R50E MDM. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/AN NW DIRECTION, AND, 1490 FEET IN A/VAN SE DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
