THIS CERTIFICATE OF LOCATION IS HEREBY MADE, POSTED, AND RECORDED TO INCLUDE ANY AND ALL OPEN GROUND WHICH MAY EXIST AS OF THIS DATE WITHIN THE BOUNDARIES OF THIS LODE CLAIM AS MONUMENTED.
