THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 630' N 50' W, TOWNSHIP 25 N, RANGE 50 E, FROM SE 60' SW 1/4 Sec. 34, SAID CLAIM LIES WITHIN THE SW 1/4, MOUNT DIABLO MERIDIAN, NEVADA. FROM THIS DISCOVERY MONUMENT, THE UNDERSIGNED CLAIMS 10 FEET IN AN/AN SE DIRECTION, AND, 1490 FEET IN A/AN NW DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
