THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 1490' N 55E FROM SW 1/4 NE 1/4 Sec. 3, TOWNSHIP 25 N, RANGE 50E MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE N 1/4 SW 1/4 UNDESIGNED CLAIMS 10 FEET IN AN/AN NW DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
