THE DISCOVERY MONUMENT IS LOCATED APPROXIMATELY 940' N68E
FROM SURCN NW 1/4 Sec. 3, TOWNSHIP 25N, RANGE 50E
MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE NW 1/4 Sec. 3
UNDERSIGNED CLAIMS 10 FEET IN AN/AN SE DIRECTION, AND, 1490
FEET IN A/VAN NW DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
OF THE VEIN. THE CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.
