MOUNT DIABLO MERIDIAN, NEVADA. SAID CLAIM LIES WITHIN THE SW 1/4
Sec. 3 T25 N R50E MDN. FROM THIS DISCOVERY MONUMENT, THE
UNDERSIGNED CLAIMS 10 FEET IN AN/AN NW DIRECTION, AND, 1490
FEET IN A/AN SE DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE
