SAID CLAIM LIES WITHIN THE SE 1/4 Sec. 3, NW 1/4 Sec. 10, FROM SE 1/4 Sec. 4, TOWNSHIP 25 N, RANGE 50E, MOUNT DIABLO MERIDIAN, NEVADA.
