SAID CLAIM LIES WITHIN THE SW 1/4 Sec. 3, SE 1/4 Sec. 4, UNDESIGNED CLAIMS 10 FEET IN AN/AN NW DIRECTION, AND, 1490 FEET IN A/AN SE DIRECTION, AND, 300 FEET ON EACH SIDE OF THE MIDDLE OF THE VEIN.
