The general course of the lode or vein is North and South.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending

Southerly direction, together with 300 feet on each side of the center of the ledge for the
entire length of the claim.

thence, East 600 feet to the Northeast Corner, a 3" in diameter by 5' in length PVC Pipe,
the point and place of beginning.

The Monumentation and marking of the exterior boundaries of this claim was completed by the
