To tie this claim to the Public Survey, begin at the SW corner of Section 3, Township 19 North, Range 49 East, Mount Diablo Base and Meridian, thence 700 feet South and 7150 feet East to the Northeast corner of this claim.

The general course of the lode or vein is North and South.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1490 feet from the location monument in a Northerly direction and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

thence, North	750	feet to the Northwest Corner, a 3" in diameter by 5' in length PVC Pipe,
thence, East	600	feet to the Northeast Corner, a 3" in diameter by 5' in length PVC Pipe,

The Monumentation and marking of the exterior boundaries of this claim was completed by the 27th day of November, 1990.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the lode claim filing fee has been paid to the County Recorder.
