The general course of the lode or vein is North and South.

We (or I) claim 1500 linear feet along the course of the ledge, lode or vein, extending 1490 feet from the location monument in a Northerly direction and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The Monumentation and marking of the exterior boundaries of this claim was completed by the _____ day of November, 1990.
