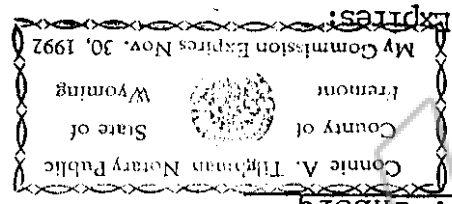

To tie this claim to the Public Survey, begin at the Southeast corner, Section 24, Township 17 N., Range 53 E., Mt. Diablo P.M., and bear N 20° W, 12378 feet and S 70° W, 6915 feet to the northeast corner of this claim.

The general course of the vein or lode is N 20° W and S 20° E.
