

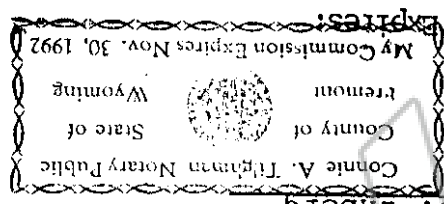

The work of location consisted of making the maps as provided in NRS 517.040. Dated November 30 A.D., 1990 and filed in duplicate.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a N 20° W direction and 10 feet in a S 20° E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
The general course of the vein or lode is N 20° W and S 20° E.
