Thence, 600 feet in a N 70° E	direction to Post No. 1, marked - B 24	-1

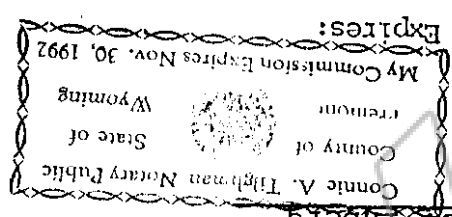
