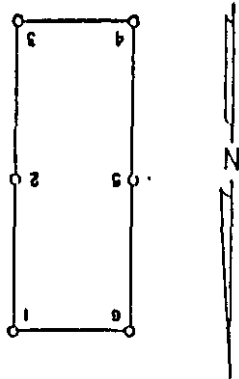
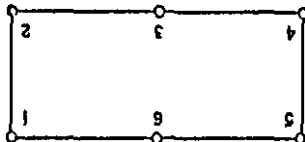

CERTIFICATE OF LOCATION - NEVADA

Beginning at the northeast corner post No. 1,

Thence, 750 feet in a S 20° E	direction to Post No. 2, marked - B 37	-2
Thence, 750 feet in a S 20° E	direction to Post No. 3, marked - B 37	-3
Thence, 600 feet in a S 70° W	direction to Post No. 4, marked - B 37	-4
Thence, 750 feet in a N 20° W	direction to Post No. 5, marked - B 37	-5
Thence, 750 feet in a N 20° W	direction to Post No. 6, marked - B 37	-6
Thence, 600 feet in a N 70° E	direction to Post No. 1, marked - B 37	-1

the point of beginning and all posts being 3 3/4" X 3 3/4" X 4' wood

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a N 20° W direction and 10 feet in a S 20° E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N 20° W and S 20° E.

To tie this claim to the Public Survey, begin at the Southeast corner, Section 24, Township 17 N., Range 53 E., Mt. Diablo P.M., and bear N 20° W, 12378 feet and S 70° W, 12915 feet to the northeast corner of this claim.

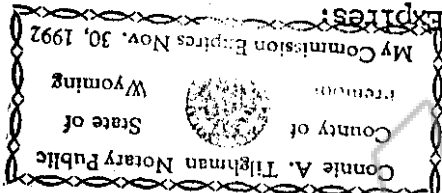
