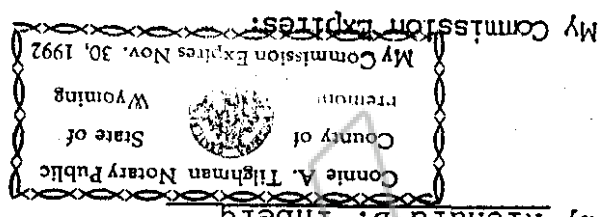

The work of location consisted of making the maps as provided in NRS 517.040. Dated November 30, A.D., 1990 and filed in duplicate.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a N 20° W direction and 1490 feet in a S 20° E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
The general course of the vein or lode is N 20° W and S 20° E.
To tie this claim to the Public Survey, begin at the Southeast corner, Section 24, Township 17 N., Range 53 E., Mt. Diablo P.M., and bear N 20° W, 4878 feet and S 70° W, 10515 feet to the northeast corner of this claim.
