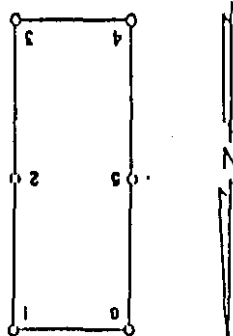
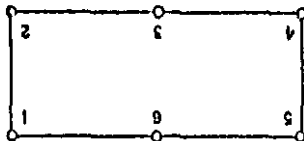

Thence, 750	feet in a	N 20° W	direction to Post No. 6, marked - B 64	-6
Thence, 600	feet in a	N 70° E	direction to Post No. 1, marked - B 64	-1

the point of beginning and all posts being 3 3/4" X 4" wood

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a N 20° W direction and 1490 feet in a S 20° E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

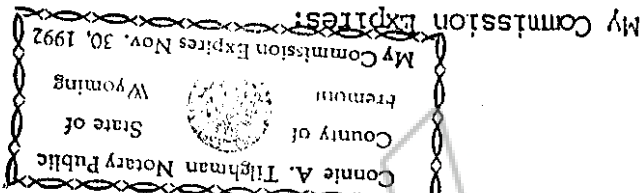
