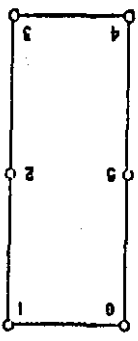
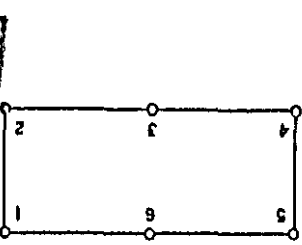

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that Richard C. Histed does hereby locate the B 73 Lode Mining Claim on this 8th day of November, 1990, situated in the Mining District, Eureka County, Nevada. Unknown
Said Claim is located in the NW(NE) (Quarter) Section(s) 24(23), Township 17 North, Range 53 East, Mt. Diablo P.M., and is more particularly described as follows, to wit:
Beginning at the northeast corner post No. 1,

Thence, 750 feet in a S 20° E	direction to Post No. 2, marked - B 73	-2
Thence, 750 feet in a S 20° E	direction to Post No. 3, marked - B 73	-3
Thence, 600 feet in a S 70° W	direction to Post No. 4, marked - B 73	-4
Thence, 750 feet in a N 20° W	direction to Post No. 5, marked - B 73	-5
Thence, 750 feet in a N 20° W	direction to Post No. 6, marked - B 73	-6
Thence, 600 feet in a N 70° E	direction to Post No. 1, marked - B 73	-1

the point of beginning and all posts being 3 1/2" X 3 1/2" X 4" wood
The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a N 20° W direction and 10 feet in a S 20° E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

The general course of the vein or lode is N 20° W and S 20° E.

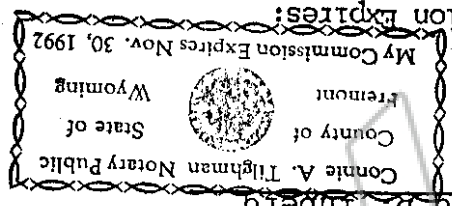
