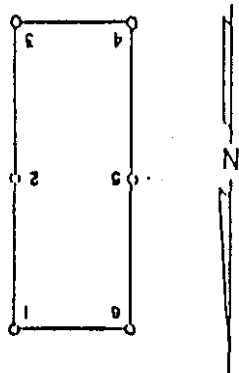
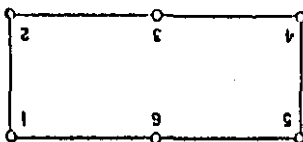

Thence, 600 feet in a S 70° W	direction to Post No. 4, marked - B 76	-4
Thence, 750 feet in a N 20° W	direction to Post No. 5, marked - B 76	-5
Thence, 750 feet in a N 20° W	direction to Post No. 6, marked - B 76	-6
Thence, 600 feet in a N 70° E	direction to Post No. 1, marked - B 76	-1

the point of beginning and all posts being 3 1/2" X 3 1/2" X 4' wood

The number of linear feet claimed in length along the course of the vein from the point of discovery is 10 feet in a N 20° W direction and 1490 feet in a S 20° E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.

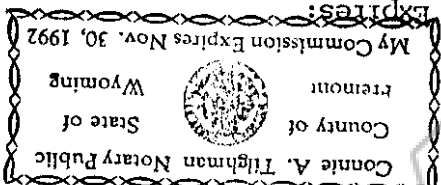
