

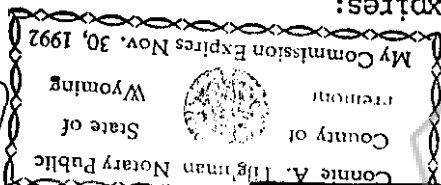

To tie this claim to the Public Survey, begin at the Southeast corner, Section 24, Township 17 N., Range 53 E., Mt. Diablo P.M., and bear N 20° W, 6378 feet and S 70° W, 2115 feet to the northeast corner of this claim.

The general course of the vein or lode is N 20° W and S 20° E.

The number of linear feet claimed in length along the course of the vein from the point of discovery is 1490 feet in a N 20° W direction and 10 feet in a S 20° E direction, together with 300 feet on each side of the center of the vein or lode for the entire length of the claim.
