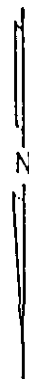
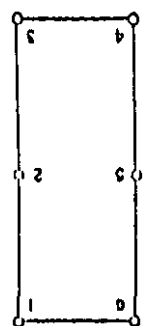
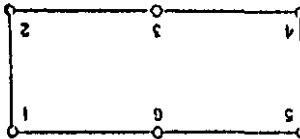

feet and N 70° E, 285 feet to the northeast corner of this claim.

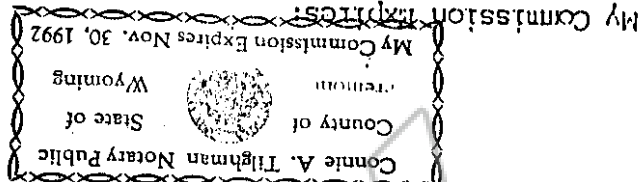
