The number of linear feet claimed in length along the course of the vein from the

feet and N 70° E, 2685 feet to the northeast corner of this Claim.

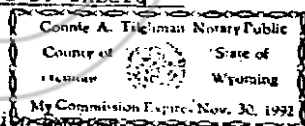
