CERTIFICATE OF LOCATION

That the following reference is hereby made to natural objects and permanent monuments so as to identify said claim, to wit:

The discovery monument is located approximately 3390 feet in a N15°E direction from the common corner of sections 14, 15, 22, 23 T16N, R48E MDM.

Within 60 days after posting notice on the ground, the locator defined the boundaries of the claim as required by law and established monuments consisting of 3.5 x 3.5 inch wooden posts, native timber, 3 inch diameter PVC pipe or rock monuments. Each monument is marked with the name of the claim and a diagram or statement indicating its location.
