AGREEMENT TO EXTEND MECHANIC'S LIEN

THIS AGREEMENT, between TONKIN SPRINGS GOLD MINING COMPANY, a Colorado corporation, as owner, and G & R Builders, Inc., a Colorado corporation qualified to do business in Nevada, as claimant,

WITNESSETH:
