**CERTIFICATE OF LOCATION OF LODE MINING CLAIM**

NOTICE IS HEREBY GIVEN that on the 11th day of October, 1990, the KV # 470 B lode mining claim was located by Kennecott Exploration Company, a Delaware corporation, whose address is 4600 Kietzke, Bldg. The claim is 1500 feet long and 600 feet wide, and 1480 feet is claimed in a southerly direction and 20 feet in a northerly direction from the location monument, at which the Notice of Location is posted together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit is from the north-south.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by marking the claim name and number on an aluminum tag.

The description of each corner is as follows:

Northwest Corner No. 1 is a 3" x 5' PVC Pipe  
Northeast Corner No. 2 is a 3" x 5' PVC Pipe  
East Side Center No. 3 is a 3" x 5' PVC Pipe  
Southeast Corner No. 4 is a 3" x 5' PVC Pipe  
Southwest Corner No. 5 is a 3" x 5' PVC Pipe  
West Side Center No. 6 is a 3" x 5' PVC Pipe
