

Pursuant to the provisions of §§30-1-71, 30-1-73 and 30-1-74 of the Idaho Business Corporation Act, as amended, the undersigned domestic corporations adopt the following Articles and Plan of Merger for the purpose of merging them into one of the such corporations:

FIRST: The following Plan of Merger was approved by the directors and shareholders of each of the undersigned corporations in the manner prescribed by the Idaho Business Corporation Act:

PLAN OF MERGER

(a) The names of the undersigned constituent corporations and the States under the laws of which they are respectively organized are:

- (b) The terms and conditions of the proposed merger are as follows:
- (i) The directors and officers of the Surviving Corporation immediately prior to the effective date of the merger shall continue to be the directors and officers of the Surviving Corporation, to hold office for the terms specified in the Bylaws of the Surviving Corporation and until their respective successors are duly elected and qualified.
- (ii) The Bylaws of the Surviving Corporation in effect immediately prior to the effective date of the merger shall continue to be the Bylaws of the

Surviving Corporation, until altered or repealed in the manner provided by law and such Bylaws.

- (iii) When the merger becomes effective, subject to such changes, adjustments or climinations as may be made in accordance with generally accepted accounting principles, the assets and liabilities of the constituent corporations shall be recorded in the accounting records of the Surviving Corporation at the amounts at which they shall be carried at that time in the accounting records of the constituent corporations.
- (iv) This Plan of Merger may be terminated and abandoned prior to the effective date of the merger upon the occurrence of any one of the following events:
 - (1) By mutual written consent of each of Constituent
 - (2) By any such parties if the Closing has not occurred by November 5, 1988.
- (v) The effective date of the merger provided for by this Plan of Merger shall be the date on which the last act required to complete the merger under the laws of the State of Idaho is performed.
- (c) The manner and basis of converting the shares of each corporation into shares of the surviving corporation shall be as follows: All of the outstanding Common Stock of each of the Constituent Corporations shall be converted into a total of 10,000 shares of the Surviving Corporation, and such 10,000 shares shall constitute all of the issued and outstanding capital stock of the Surviving Corporation.
- (d) The following changes in the Articles of Incorporation of the Surviving Corporation are to be effected by the merger: Article I of the Articles of Incorporation of the Surviving Corporation is hereby amended to read as follows:

"The name of this corporation shall be AGRI BEEF CO."

Article VII of the Articles of Incorporation of the Surviving Corporation is hereby amended to read as follows:

"That the amount of total authorized capital stock is 15,000 shares, with No Par Value."
