AGREEMENT FOR TERMINATION OF JOINT VENTURE

THIS AGREEMENT FOR TERMINATION OF JOINT VENTURE is made and entered into effective as of the 30th day of November, 1990, by and between the following parties (collectively, the "Parties"), who constitute all of the members of the Bullion-Monarch Venture, aka Bullion-Monarch Joint Venture (the "Joint Venture"), which was established pursuant to that certain Amended and Restated Venture Agreement, dated April 15, 1986 (the "Venture Agreement"), and for which a Certificate of Business; Ficticious Firm Name was recorded in the records of Eureka County, Nevada, on August 2, 1990, in Book 212, Page 180, Reception No. 133017: Westmont Gold Inc., Delaware corporation, The Petrol Oil and Gas Corporation, Delaware corporation, United El Dorado Corporation, a Nevada corporation, Camsell River Investments Ltd., Canadian а corporation, Lambert Management Ltd., a Canadian corporation, Lambert Holdings Ltd. (successor by corporate amalgamation to Eltel Ltd.), a Canadian corporation, and Lost Dutchman Construction, Inc., a Nevada corporation.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which hereby are acknowledged by the Parties, the Parties agree as follows:

- 1. Pursuant to Section 12.1 of the Venture Agreement, the Joint Venture is terminated effective as of the date hereof.
- 2. The Parties hereby agree and confirm that Sections 12.3, 12.4, 12.5 and 12.6 of the Venture Agreement shall remain operative in accordance with their original terms.
- 3. Westmont Gold Inc., as Operator of the Joint Venture, hereby is authorized, and hereby agrees, to record this Agreement in the records of Eureka County, Nevada.
- 4. This Agreement is made subject to the rights and obligations contained in paragraph 5 of that certain Agreement dated January 15, 1990, between and among the parties hereto and their respective predecessors.
