That the first parties for and in consideration of the sum of Ten (\$10.00) dollars, lawful money of the United States of America, and other and further valuable consideration, to them in hand paid by the said second parties, the receipt whereof is hereby acknowledged, does by these presents, grant, bargain, nell and convey unto the said second parties, in Joint Tenancy, with the right of survivorship of them, and not as tenants in common, all of the following described real property, situate at and within the town of Eureka, Beyada, and more particularly bounded and described as follows, to-wit:
